**The Order Prescribing Penalty on Customs Brokerage Companies and Customs Brokers Who Apply the Extension of the Validity of Broker Licenses and Broker ID which have been Expired**

1. The Ministry of Planning and Finance, the Customs Department, by exercising the authority provided under Sea Customs Act Section 204 Sub-section (b), the procedures which have to be observed by the Customs Brokers has been notified with the notification No. 74/2020, subject to the import, export, transit of any goods, for the matters relating to the Customs, grants the permission of new establishment of Customs Brokerage or Customs Brokerage Companies to conduct the Customs Brokerage and extension of the validity.
2. Under the Paragraph 11, Sub-Para (e), the procedures which have to be observed by the Customs Brokers, the matter relating to the extension of validity which has been expired, on the expiration of Customs Brokerage (Registration), the penalty which has to be paid, upon the expiration of validity period as of the months overdue which has been stated in the Table (1), the matters relating to re-apply to conduct the Customs Brokerage by the Brokers who stopped the service after the certain period because of various reasons without any Customs offences, the validity expiration of Broker ID, the penalty as of the year overdue which has to be paid has been fixed under the Table (2), hereto attached with.
3. This order shall be affected since March 30, 2023.
